State of Rhode Island Monthly Local Hotel Tax Report FY 2016 Local 1.0 Percent Collections November 2015

In June 2010, the Rhode Island Department of Revenue began issuing a monthly report on the collection and distribution of the local 1.0 percent hotel tax. The report is meant to be descriptive and does not purport to project or assess the collection of the local 1.0 percent hotel tax. The report provides data by municipality on the month-to-month, year-over-year, and fiscal year-to-date over fiscal year-to-date collections. A discussion of the municipalities with the largest and smallest percentage and nominal changes in these three measures will be included in the body of the report.

The November 2015 local 1.0 percent hotel tax collections report may include tax receipts generated from the expansion of the local hotel tax base. Effective July 1, 2015, the reselling of lodging by online travel companies, the unlicensed rental of accommodations via internet platforms and other media, and vacation home rentals became subject to the local 1.0 percent hotel tax. At this time, the Office of Revenue Analysis is unable to identify the amount collected from each of these local hotel tax base expansion components. Thus, an unknown amount of local 1.0 percent hotel tax receipts may be captured in this report. Efforts will be made to identify local 1.0 percent hotel tax collections attributable to the expansion of the local 1.0 percent hotel tax base in future reports.

Analysis of Month-to-Month Collections

On a statewide basis, November 2015 local 1.0 percent hotel tax collections totaled \$263,219 or 31.6 percent less than the \$385,067 collected in October 2015. The two communities with a percentage increase in local 1.0 percent hotel tax collections between November 2015 and October 2015 were: North Kingstown, 320.7 percent and Little Compton, 80.0 percent. The five communities with the largest percentage decrease in local 1.0 percent hotel tax collections between November 2015 and October 2015 were: Scituate, -100.0 percent; New Shoreham, -90.1 percent; Portsmouth, -84.3 percent; Narragansett, -71.7 percent; and Bristol, -62.5 percent.

The three communities with the largest nominal increase in local 1.0 percent hotel tax collections between November 2015 and October 2015 were: North Kingstown, \$1,923; Foster, \$36; and Little Compton, \$7. The five communities with the largest nominal decrease in local 1.0 percent hotel tax collections between November 2015 and October 2015 were: Providence, \$(36,768); Newport, \$(26,048); Middletown, \$(19,746); Warwick, \$(17,341); and New Shoreham, \$(4,963).

Analysis of Year-over-Year Collections by Month

On a statewide basis, November 2015 local 1.0 percent hotel tax collections totaled \$263,219 or 13.8 percent more than the \$231,231 collected in November 2014. The five communities with the largest percentage increase in local 1.0 percent hotel tax collections between November 2015 and November 2014 were: West Greenwich, 188.2 percent; Bristol, 150.8 percent; Westerly, 98.9 percent; Glocester, 93.9 percent; and Cranston, 74.5 percent. The five communities with the largest percentage decrease in local 1.0 percent hotel tax collections between November 2015 and November 2014 were: Scituate, -100.0 percent; Little Compton, -41.7 percent; New Shoreham, -16.6 percent; Charlestown, -15.6 percent; and East Providence, -9.9 percent.

The five communities with the largest nominal increase in local 1.0 percent hotel tax collections between November 2015 and November 2014 were: Newport, \$13,908; Westerly, \$6,273; Warwick, \$5,387; West Greenwich, \$2,063; and Middletown, \$1,624. The five communities with the largest nominal decrease in local 1.0 percent hotel tax collections between November 2015 and November 2014 were: Providence, \$(2,345); Scituate, \$(159); East Providence, \$(156); New Shoreham, \$(108); and Charlestown, \$(21).

Analysis of Fiscal Year-to-Date Collections through November

On a statewide basis, fiscal year-to-date November 2015 local 1.0 percent hotel tax collections totaled \$2.20 million or 12.9 percent more than the \$1.95 million collected in fiscal year-to-date November 2014. The five communities with the largest percentage increase in local 1.0 percent hotel tax collections between fiscal year-to-date November 2015 and fiscal year-to-date November 2014 were: Cranston, 77.8 percent; East Greenwich, 63.3 percent; West Greenwich, 34.0 percent; Portsmouth, 31.4 percent; and North Smithfield, 29.3 percent. The four communities with a percentage decrease in local 1.0 percent hotel tax collections between fiscal year-to-date November 2014 were: Computer 2015 and fiscal year-to-date November 2014 were: The four communities with a percentage decrease in local 1.0 percent hotel tax collections between fiscal year-to-date November 2014 were: Foster, -32.6 percent; Little Compton, -31.1 percent; North Kingstown, -8.1 percent; and Jamestown, -7.4 percent.

The five communities with the largest nominal increase in local 1.0 percent hotel tax collections between fiscal year-to-date November 2015 and fiscal year-to-date November 2014 were: Newport, \$64,919; Providence, \$51,538; Warwick, \$34,226; Westerly, \$27,571; and Middletown, \$17,393. The four communities with a nominal decrease in local 1.0 percent hotel tax collections between fiscal year-to-date November 2015 and fiscal year-to-date November 2014 were: North Kingstown, \$(1,526); Jamestown, \$(239); Little Compton, \$(44); and Foster, \$(17).
