## State of Rhode Island Monthly Meal and Beverage Report FY 2016 Local 1.0 Percent Collections April 2016

In June 2010, the Rhode Island Department of Revenue began issuing a monthly report on the collection and distribution of the local 1.0 percent meal and beverage tax. The report is meant to be descriptive and does not purport to project or assess the collection of the local 1.0 percent meal and beverage tax. The report provides data by municipality on the month-to-month, year-over-year, and fiscal year-to-date-over-fiscal year-to-date collections. The data contained in the report is for the month in which the meal and beverage sales activity occurred. The receipts generated from this activity were paid to the Division of Taxation the month following the sales activity and distributed to the municipalities the month after receipt by the Division of Taxation.

#### **Analysis of Month-to-Month Collections**

On a statewide basis, April 2016 local 1.0 percent meal and beverage tax collections totaled \$2.0 million, \$17,923 or 0.9 percent less than the \$2.02 million collected in March 2016. The five communities with the largest percentage increases / decreases in local 1.0 percent meal and beverage tax collections between April 2016 and March 2016 were:

#### **Analysis of Year-over-Year Collections by Month**

On a statewide basis, April 2016 local 1.0 percent meal and beverage tax collections totaled \$2.0 million, \$87,130 or 4.5 percent more than the \$1.92 million collected in April 2015. The five communities with the largest percentage increases / decreases in local 1.0 percent meal and beverage tax collections between April 2016 and April 2015 were:

#### **Analysis of Fiscal Year-to-Date over Fiscal Year-to-Date Collections**

On a statewide basis, fiscal year-to-date April 2016 local 1.0 percent meal and beverage tax collections totaled \$20.88 million, \$1.6 million or 8.3 percent more than the \$19.28 million collected in fiscal year-to-date April 2015. The five communities with the largest percentage increases / decreases in local 1.0 percent meal and beverage tax collections for fiscal year-to-date April 2016 versus fiscal year-to-date April 2015 were:
