State of Rhode Island Monthly Local Hotel Report FY 2015 Local 1.0 Percent Collections November 2014

Beginning in June 2010, the Rhode Island Department of Revenue will issue a monthly report on the collection and distribution of the local 1.0 percent hotel tax. The report is meant to be descriptive and does not purport to project or assess the collection of the local 1.0 percent hotel tax. The report provides data by municipality on the month-to-month, year-over-year, and fiscal year-to-date-over-fiscal year-to-date collections. A discussion of the municipalities with the largest and smallest percentage and nominal changes in these three measures will be included in the body of the report.

Analysis of Month-to-Month Collections

On a statewide basis, November 2014 local 1.0 percent hotel tax collections totaled \$231,231 or 36.5 percent less than the \$364,082 collected in October 2014. The one community with a measurable percentage increase in local 1.0 percent hotel tax collections between November 2014 and October 2014 was: East Greenwich, 35.1 percent. The five communities with the largest percentage decrease in local 1.0 percent hotel tax collections between November 2014 and October 2014 were: Bristol, -82.8 percent; Portsmouth, -74.9 percent; Glocester, -70.8 percent; Charlestown, -66.1 percent; and Middletown, -64.8 percent.

The two communities with a nominal increase in local 1.0 percent hotel tax collections between November 2014 and October 2014 were: Little Compton, \$27; and East Greenwich, \$5. The five communities with the largest nominal decrease in local 1.0 percent hotel tax collections between November 2014 and October 2014: Newport, \$(50,165); Providence, \$(21,584); Middletown, \$(20,453); Warwick, \$(14,877); and Westerly, \$(7,923).

Analysis of Year-over-Year Collections by Month

On a statewide basis, November 2014 local 1.0 percent hotel tax collections totaled \$231,231 or 10.9 percent more than the \$208,572 collected in November 2013. The five communities with

On a statewide basis, November 2014 local 1.0 percent hotel tax collections totaled \$231,231 or 10.9 percent more than the \$208,572 collected in November 2013. The five communities with the largest percentage increase in local 1.0 percent hotel tax collections between November 2014 and November 2013 were: Johnston, 1,429.6 percent; Coventry, 51.5 percent; Narragansett, 46.0 percent; Richmond, 37.9 percent; and East Providence, 33.9 percent. The five communities with the largest percentage decrease in local 1.0 percent hotel tax collections between November 2014 and November 2013 were: West Greenwich, -53.6 percent; New Shoreham, -44.1 percent; North Smithfield, -41.7 percent; Bristol, -40.1 percent; and Glocester, -36.8 percent.

The five communities with the largest nominal increase in local 1.0 percent hotel tax collections between November 2014 and November 2013 were: Providence, \$9,703; Newport, \$8,656; Warwick, \$1,514; Westerly, \$1,010; and Middletown, \$893. The five communities with the largest nominal decrease in local 1.0 percent hotel tax collections between November 2014 and November 2013 were: West Greenwich, \$(1,264); New Shoreham, \$(514); Bristol, \$(261); Woonsocket, \$(185); and Pawtucket, \$(114).

Analysis of Fiscal Year-to-Date Collections through November

On a statewide basis, fiscal year-to-date November 2014 local 1.0 percent hotel tax collections totaled \$1.95 million or 8.1 percent more than the \$1.81 million collected in fiscal year-to-date November 2013. The five communities with the largest percentage increase in local 1.0 percent hotel tax collections between fiscal year-to-date November 2014 and fiscal year-to-date November 2013 were: Foster, 65.6 percent; Portsmouth, 46.1 percent; Scituate, 40.8 percent; Johnston, 33.2 percent; and Jamestown, 32.8 percent. The five communities with the largest percentage decrease in local 1.0 percent hotel tax collections between fiscal year-to-date November 2014 and fiscal year-to-date November 2013 were: Little Compton, -92.1 percent; Glocester, -23.0 percent; Cranston, -11.7 percent; West Greenwich, -11.4 percent; and Charlestown, -7.8 percent.

The five communities with the largest nominal increase in local 1.0 percent hotel tax collections between fiscal year-to-date November 2014 and fiscal year-to-date November 2013 were: Newport, \$50,358; Westerly, \$23,318; Middletown, \$21,569; Warwick, \$18,584; and Providence, \$18,143. The five communities with the largest nominal decrease in local 1.0 percent hotel tax collections between fiscal year-to-date November 2014 and fiscal year-to-date November 2013 were: West Greenwich, \$(2,227); Little Compton, \$(1,620); Charlestown, \$(500); Cranston, \$(251); and Glocester, \$(117).
